Overview of Annual Health Bulletins and other health reports of the Countries


Input for Regional Database on health situation and trends in the South-East Asia Region is provided by countries through their annual health bulletins and reports which in turn provide data-based evidence to the process of preparation of regional publications on health situation in the South-East Asia Region as shown in the diagram on next page

Annex 1 lists the potential publications either already provided or likely to be provided by countries of the Region for documentary evidence on health situation and its trends in the respective country. These publications are the main sources for preparation of regional publication.

Regional issues and challenges

- Ministries of Health in SEAR countries do have health information teams to oversee directly or indirectly the operations of the data recording and reporting mechanisms. However, countries have not been able to use health information effectively for policy debate and decision making due to:
 - ◆ Data collection systems are overloaded with details, which may not be required for policy/decision-making.
 - The appropriate feedback mechanisms are not well established.
 - weak linkages in the data transmission system at various levels.
 - Required information is not available in a timely manner. Sometimes it is incomplete and thus not usable for evidence-based decision-making..
- > Organizational culture which values or encourages analytical thinking is lacking.
- NHIS are often found not adequately equipped with global tools & techniques of data analysis.
- Appropriate tools for transforming data into information for decision-making are not always applied properly.
- Disaggregated data are often not available in the form required by programme managers for day to day decision-making.at point of delivery of health service.
- Existing human resources are not sufficiently trained for applying the latest analytical tools and methods to synthesize information for decision-making.
- Health information systems are not well equipped for emergency preparedness and vulnerability reduction. Therefore, it is not responsive enough to help contain natural disasters and emergencies.
